BOOKING POLICY: AT THE TIME OF BOOKING, A 50% NON-REFUNDABLE RETAINER FEE IS REQUIRED TO HOLD YOUR DATE AND TIME. THIS IS DUE TO POTENTIAL LOSS OF OTHER CLIENTS, CHILDCARE EXPENSES DURING YOUR SESSION AND FEES ASSOCIATED WITH YOUR SESSION AND THEREAFTER. YOUR SESSION FEE DEPOSIT CAN BE MADE IN THE FORM OF CASH, CHECK, or VIA PAYPAL OR VENMO. APPOINTMENTS MADE WITHOUT A DEPOSIT MAY NOT BE HONORED AND ARE SUBJECT TO CANCELLATION.

THE CLIENT UNDERSTANDS THAT THEIR SESSION IS NOT CONFIRMED UNTIL THE 50% RETAINER IS PAID. WEATHER CANCELLATIONS WILL BE MADE AT THE PHOTOGRAPHER'S DISCRETION. TARDINESS WILL NOT DELAY MY SESSION. MY SESSION WILL REMAIN WITHIN THE SCHEDULED TIME FRAME. IF I NEED TO RESCHEDULE I WILL GIVE CONTACT WITHIN 24 HOURS OF SAID RESERVED SESSION DATE, OTHERWISE I FORFEIT TRANSFER OF MY RETAINER FOR A NEW SESSION DATE.

LATE FEE: IN THE EVENT THAT THE CLIENT ARRIVES MORE THAN 15 MINS LATE FOR THE SCHEDULED SESSION, A \$40 LATE FEE CHARGE WILL BE ADDED TO THE FINAL BILL.

PAYMENT POLICY: SESSIONS MUST BE PAID IN FULL BEFORE OR ON THE SHOOTING DATE VIA CASH, VENMO OR PAYPAL. AN ADDITIONAL \$40 SURCHARGE WILL BE ADDED TO ALL SESSIONS WHERE THE CLIENT IS BEYOND 15 MINUTES LATE. SESSION END TIMES WILL NOT BE EXTENDED TO ACCOMMODATE CLIENT LATENESS.

RESCHEDULING FEE: IN THE EVENT THAT THE CLIENT MUST RESCHEDULE, A \$50 FEE WILL BE CHARGED.

CANCELLATION POLICY: IF YOU ARE UNABLE TO MAKE YOUR PHOTO SESSION ALL DEPOSITS WILL ACT AS A CANCELLATION FEE. 72 HOURS OF ADVANCE NOTICE OF CANCELLATION IS REQUIRED TO CREDIT THE DEPOSIT TOWARDS A FUTURE SESSION. THE PHOTOGRAPHER RESERVES THE RIGHT TO DENY SERVICE TO ANY CLIENT(S) WHO REPEATEDLY HAVE A HISTORY OF CANCELLATIONS.

IF STOOPIMAGES CANNOT PERFORM THIS CONTRACT DUE TO FIRE OR ANOTHER CASUALTY, STRIKE, THE ACT OF GOD, OR OTHER CAUSE BEYOND THE CONTROL OF THE PARTIES, OR DUE TO THE PHOTOGRAPHER'S ILLNESS OR EMERGENCY, THEN THE PHOTOGRAPHER SHALL RETURN THE RETAINER FEE TO THE CLIENT BUT SHALL HAVE NO FURTHER LIABILITY CONCERNING THE CONTRACT. THIS SHALL ALSO APPLY IF PHOTOGRAPHIC MATERIALS ARE DAMAGED IN PROCESSING, LOST THROUGH THE CAMERA OR OTHER MEDIA MALFUNCTION, LOST IN THE MAIL, OR OTHERWISE LOST OR DAMAGED WITHOUT FAULT ON THE PART OF THE PHOTOGRAPHER.
